How to Enter the Fair:

Exhibitor Handbook available for printing on our website www.sanbenitocountyfair.com

1. Visit <http://sanbenito.fairwire.com> for the SBCF online entries home page, entries open July 15th. Please see Dates to Remember in handbook.
Livestock Exhibitors MUST have your Tag Id's, Scrapie Id's, Leg Band numbers, Registration Papers & completed YQCA Certificate by entry close date. Entry will be invalid if Tag Id information is missing or incorrect.
Please have necessary documents ready to upload
Hog Exhibitors need Prop 12 certification form information from their breeder

2. Register as a "new" exhibitor. Complete the steps required for your personal information
3. Click "Add Entry" and choose a "Department".
4. Within each department you will be asked to choose a "Class" and information pertaining to your entry
 - a. Please answer each question accurately
 - b. You may add additional information such as a Title or a Description about your item
 - c. Continue to add additional entries
 - d. Pay special attention to filling out your entries. Be sure that your name, address, and city are clear on each section. Whenever signatures on affidavits are necessary, be sure they are supplied. Check your department, division, and class numbers carefully with the Exhibitor Handbook prior to entering. Wrong department, division or class numbers appearing can lead to disqualification if not corrected in time.
 - e. Please don't hesitate to check with the Fair entry office during business hours 831-628-3421 or email anytime entry@sanbenitocountyfair.com.
5. When entries are complete, follow the prompts to complete your shopping cart and pay for your entries
 - Remember! You must click "Save Cart" in order for your account to be saved
 - After "saving your cart" you may come back to pay at a later date (but don't forget!)
 - Any "carts" not paid for by August 25th, at 11:59 pm will not be accepted! **NO EXCEPTIONS!!**
6. **ENTRY CHANGES:** If you have completed your entries and need changes or additions, the Entry Office will be available August 20th – August 25th, 9:00 am - 6:00 pm.
7. Depending on your division entered, you may be prompted to upload a photo or documents, for example:
 - a. Photos of the item
 - b. Presentation of Demonstration videos must be email to entry@sanbenitocountyfair.com by August 25th.
8. Print out your receipt! This is your proof that you did indeed make the entry deadline

TAG ID'S – MULTIPLE TAG ID'S PER EXHIBITOR: EACH TAG ID MUST BE ENTERED AS AN ENTRY BY ENTRY DEADLINE. ENTRIES WILL BE INVALID OTHERWISE.

- Tagging **MUST** be done by specie Leader / Advisor for all Market – Sheep, Goats, and Hogs. Beef Tagging will be done by specie Chair.
- Tags are NOT to be given out for self-tagging.
 - Full front head photo with ear notching (if applicable) & Tag Id on Hogs. Ear Tag Id & Scrapie Tag MUST be present on Sheep & Goats, Tag Id on Beef.
 - MUST be visible and legible
 - Full back head photo of animal
 - Full body side photo view of animal
 - Photos: Beef photos will be done by Beef Chair and are due with Tagging Sheet June 3rd at 8:00 pm.
Goats, Sheep, Hogs are due with tagging sheet by August 2nd at 4:00 pm.
NO EXCEPTIONS!

REMINDER - In case of lost required Tag Id, exhibitor **MUST** notify Entry Office within 24 hours. Specie Chairperson will be notified, and arrangements made to retag animal. Failure to report will result in disqualification of entry.

- U-Barn will be used for Fitting Area ONLY (Goats – Sheep – Beef). Sections will be marked.
- Large Generator with appropriate boxes and outlets will be provided. Personal Generators are allowed but ONLY in designated area and appropriate cords. **NO EXCEPTIONS!**
- **NO CANOPIES ALLOWED! NO EXCEPTIONS.**
- Premium Beef Fitting spots available at Barn H. \$25.00 each. Limited spots available. Limit 1 per exhibitor. 1st COME, 1st SERVE – LIMITED QUANTITY. Purchase at the Livestock Office, September 28th from 3:00 pm – 5:00 pm.
- **WEIGH-IN AND CHECK-IN DAY:**
 - Tag Id's, Scrapie Tags (USDA REQUIRED) and ALL necessary Registration Papers will be verified.
- **LIVESTOCK CLASSES:**
 - **ALL** Livestock Classes will follow the Livestock Schedule **ONLY**, please see Handbook.
- **4-H, INDEPENDENT AND FFA EXHIBITORS:**
 - Do Not forget your **MANDATORY** Still Exhibit for Market Livestock for all 4-H, Independent, FFA Livestock Exhibitors (exception with Primary Members for Rabbits & Poultry).
 - YQCA Certificates must be completed and uploaded by entry deadline, August 25th.
 - Please upload necessary paperwork and photos online with entries.
 - **Entry will be invalid if Tag Id information is missing or incorrect.**
- **TACK OUT:**
 - Sunday, October 6th, 4:30 pm
- **HOGS:**
 - **Prop 12 Requirement:** Please use **Official Form at back of Handbook**. For more information, please visit <https://www.cdfa.ca.gov/AHFSS/AnimalCare/docs/AnimalCareFairsExhibitions.pdf>
- **ALL** Market Livestock Exhibitors **MUST** complete the YQCA Program online prior to Entry Deadline
- **ALL** Market Livestock Exhibitors **MUST** enter a Still Exhibit

BREEDING / FEEDERS

- ALL Registered Livestock is required to show paperwork at check-in. Please have ready.
- Breeding animals and Feeders can be released / loaded out before 8:00 am any day after their show day and **MUST** be removed from the grounds by 3:00 pm Friday, October 4th. Animals may not be removed after 8:00 am unless deemed necessary by the Chairperson and Veterinarian for health reasons.
- **MUST** obtain a Release Form from the Livestock Office prior to loading animal.
- Dairy Cattle and Dairy Goats are open to San Benito, Monterey, Santa Cruz, Merced, Santa Clara, and Stanislaus counties
- Limited to 20 out of County

SHOWMANSHIP

- Showmanship fee is included with entry fee. **Class MUST be entered separately in ShoWorks by entry deadline.** No refunds for non-participation.
- Round Robin – Exhibitors will be required to bring the following tools: Beef Scotch Comb, Beef Show Stick, and a Swine Whip / Stick.

- Round Robin – In the event of a tie score, the Exhibitor who placed higher in the most classes will win the tie. If the tie cannot be broken based on placing, each Exhibitor will be asked a tie breaker question. Questions will be determined and asked by the Round Robin judges.

JUNIOR LIVESTOCK AUCTION

- Auction is a terminal sale. No market animals will be live pick up
- If a market animal is removed from the property by the exhibitor or any affiliation after weigh-in consignment, the exhibitor will become ineligible to show or sell livestock at any future San Benito County Fair.
- Buyer letters and Add-On forms are extremely important and are strongly encouraged. Please send out at least 3 per exhibitor.
- **Thank You letters for buyer(s) are mandatory. Please have them ready to mail and turn in to your Leader or Advisor by 2:00 pm. Leaders and Advisor's please turn in by Sunday, October 6th in the Livestock Office before 2:00 pm.**
- Auction checks will be available for pick up on November 15th (subject to change). A \$50.00 fee will be applied to any reprinted, stale, or lost checks.

2024 CALIFORNIA FAIRS STATE RULES

Local Rules and Regulations

1. Exhibitors are expected to familiarize themselves with these rules and to abide by them. All departments in the 2024 San Benito County Fair are open to residents and producers of the 33rd District Agricultural Association (San Benito County). In case of non-residents, producer means bona fide property owners in San Benito County during 2024, the status of which will be determined by the management of the Association through inspection of the county tax records. Also, producers must regularly grow or raise the produce exhibited in San Benito County; if not, their land must be part of that owned or operated in San Benito County. All decisions will be final. Some departments have opened their entries to a wider area. Please check each department to see if other counties are eligible.
2. **CLOSING DATE FOR ENTRIES:** August 25th until 11:59 pm.
NO refunds will be made.
3. **JUDGING OF EXHIBITS:** Will occur between Sunday, September 29th and Friday, October 4th. See judging schedule in Handbook. American System of Judging: each judged in competition with other entries in its class unless otherwise stated. Danish System of Judging: based upon established standards of quality for each type of product; each exhibit is judged according to how well it meets that standard rather than how it compares with other exhibits.
4. **DAMAGE TO STOCK:** The Board of Directors will use every precaution in their power for the safe preservation of all articles and stock on exhibition, but will not be accountable for loss or damage, whatever may be the cause or the extent of damage done. Exhibitors must give attention to their articles or animals during the Fair and at the close of the exhibition.
5. **PAYMENT OF PREMIUMS:** Checks will be issued for premiums as soon as possible after the close of the Fair.
6. **UNDELIVERED PREMIUMS FORFEITED:** All premiums awarded by the Association will be mailed to the address given on entry form. Undeliverable premiums will be forfeited to the State of California.
7. **UNCLAIMED AWARDS:** After 30 days, any unclaimed exhibits or awards become the property of the 33rd District Agricultural Association and may be disposed of.
8. **REJECTION OF EXHIBITS:** The Association reserves the right to reject any exhibit improperly entered, or when the ownership is in doubt, or if required entry fees are lacking, or if not properly conditioned for the show.
9. **REMOVAL OF EXHIBIT:** No exhibit will be removed before the date and time stated in the rules for each department as provided in State Rule II-14 and Auction Sales Rules. (Early removal will result in forfeiting any premiums due to the exhibitor. This rule will be rigidly enforced.) Due to the possibility of loss, ribbons may not be placed on display. Ribbons and premium checks will be available in the department when you pick up your exhibits.
10. **NO DOGS.** Exception for ADA Authorized Service Dogs are allowed.
11. **CAMPING:** Will be in the upper picnic area. Minors must be accompanied by parent / guardian. No underage drinking allowed. Proof of insurance and registration must be presented with reservation. See Camping Page for details.
12. **FINAL CLOSING:** The Fair will close Exhibits to visitors on Sunday, October 6th, 6:00 pm.
13. **SAN BENITO COUNTY 4-H PARTICIPATION REQUIREMENTS:** Membership in the University of California, San Benito County 4-H Program is open to all children in kindergarten through 19 years of age without regard to race, religion, sex or physical handicap who reside within San Benito County school district boundaries and/or are legally in attendance at a San Benito County school. Youth residing in a county other than San Benito must have the approval of the 4-H Youth Development Advisor from their home county and the San Benito County 4-H Youth Development Advisor and the community club leader of the club he/she seeks to join. Families enrolled in a San Benito 4-H club prior to this policy being implemented, will be allowed to continue participating in the program as long as they have the approval of

the 4-H Youth Development of both counties annually. SBCF recognizes all 4-H enrollment requirements.

14. **MONTEREY AND SANTA CRUZ COUNTY PARTICIPATION REQUIREMENTS:** Must be enrolled in a 4-H Club Program based in Monterey or Santa Cruz County. FFA exhibitors must be enrolled in a FFA Chapter in a Monterey or Santa Cruz school. Exhibitor must live within eligible counties to exhibit.
15. **FRAUDULENT ENTRIES:** If after the judges have made their awards, the Association finds that an exhibitor has improperly and falsely entered any exhibit, said exhibitor will forfeit all rights to all premiums that may have been awarded him / her in all departments of the Fair.
16. **CANCELLED ENTRIES:** Exhibitors canceling their entries in Livestock or Horse Show for any reason after the official date for the closing of the entries, excepting written verification by a qualified veterinarian, shall forfeit their entry fees. Veterinary certificates must state the date of inspection and the nature of disqualification and must be filed in the Fairgrounds office at least 24 hours prior to the start of the Fair. This rule will be rigidly enforced.
17. **LEADER / ADVISOR SIGNATURE PROCEDURE:** Due to the online entry program our process to obtain 4-H leader and FFA advisor signatures is as follows: after entry closing date a list of all online entries (livestock and non-livestock) for each club and chapter will be emailed to the 4-H Community Leader / FFA Advisor / Grange Leader. There will be an email for each leader / advisor to verify that all entries are valid projects and eligible to exhibit at the 2024 fair. This signed sheet **MUST** be emailed or postmarked by September 14th (no metered mail).
18. **STILL EXHIBIT RULE – REQUIRED 2024**

Attention **ALL** 4-H, Independent and FFA exhibitors!

Entering exhibits in any MARKET class: Each Market Exhibitor is required to enter and deliver at least one entry in either the 4-H Stills or FFA Stills. All entries must have been made, collected, grown or prepared within one year of the opening date of the 2024 fair.

Educational Posters DO NOT satisfy the Still requirement

Failure to deliver the REQUIRED Still entry will result in DISQUALIFICATION of ALL Market entries for current year's fair. Animals will be sent home NO exceptions!

 - 4-H, FFA, Grange Members and Independent Juniors residing in San Benito, Santa Cruz, and Monterey Counties
- **BILL OF SALE:**
 - Must be made out to individual exhibitor for Beef entries ONLY
- **SWINE PROP 12**
 - Please use Official Form at back of Guidebook. For more information, please visit <https://www.cdfa.ca.gov/AHFSS/AnimalCare/docs/AnimalCareFairsExhibitions.pdf>
- **LOSS OF EAR TAG:**
 - In case of lost required ear tag exhibitor **MUST** notify Entry Office within 24 hours. Species Chairperson will be notified, and arrangements made to retag animal. Failure to report will result in disqualification of entry.
- **NO GLITTER OR WRITING ON ANY ANIMAL:**
 - Any kind on any animal will result in forfeiture of awards and or monies
- **LIVESTOCK WEIGH-IN:**
 - All market livestock (Beef, Goats, Sheep, and Swine) will be allowed on grounds in assigned stalls, starting at 8:00 am and **MUST** be in place by 6:00 pm, Tuesday, October 1st. Animals go to their stalls on arrival and wait in line from their stalls when scales open. Animals will **NOT** be weighed off trailer!! Exhibitor **MUST** be present for their animal Weigh-In or designate a fellow youth exhibitor, in writing to the Entry Office by 5:00 pm, Monday, September 30th. **NO EXCEPTIONS!**
 - Hogs weigh-in from 2:00 pm – 6:00 pm
 - Sheep, and Goats weigh-in from 3:00 pm – 6:00 pm
 - Beef weigh-in from 4:00 pm – 5:30 pm
- **STALLS AND PENS:**
 - **MUST BE NEATLY KEPT**
 - Exhibitors must provide their own bedding. Pathways, approaches, and aisles between barns **MUST** be kept clean for the convenience of spectators. This work must be completed by 7:30 am each day. **NO EXCEPTIONS!**
- **RECEIVING TIME FOR JUNIOR BREEDING ANIMALS:**
 - Tuesday, October 1st for Swine, Sheep, Dairy Goats and Commercial Meat Does, Beef, and Dairy Cattle by 6:00 pm
 - Livestock arriving at the Fair will be inspected by the Specie's Chair by 6:00 pm prior to weigh-

in. Livestock will be thoroughly checked for fungus and any health-related problems. Livestock with health issues will not be allowed to show and must be removed from the fairgrounds immediately.

- **BREEDING / FEEDER ANIMALS:**
 - Beef Cattle, Sheep, Goats and Hogs in the Junior Divisions are open to Monterey, San Benito, and Santa Cruz County residents.
 - Dairy Cattle and Dairy Goats are open to San Benito, Monterey, Santa Cruz, Merced, Santa Clara, and Stanislaus counties. LIMITED TO 20 OUT OF COUNTY.
 - Breeding animals and Feeders are released after their show. They can be loaded out before 8:00 am any day after their show and MUST be removed from the grounds by 3:00 pm Friday, October 4th. Animals may not be removed after 8:00 am unless deemed necessary by the Chairperson and Veterinarian for health reasons.
- **ENTRIES RELEASED:**
 - Fair closes on Sunday, October 6th at 6:00 pm. Please stage items to be loaded and observe a 5-MINUTE loading time limit. EDUCATIONAL MATERIALS MUST BE LEFT IN PLACE UNTIL 4:30 pm Sunday, October 6th.
 - Excess tack may be WALKED all the way out any day before 8:00 am or after 10:00 pm and may be driven out Sunday, October 6th between 4:30 pm - 5:30 pm
- **SAN BENITO COUNTY MARKET EXHIBITORS WILL BE LIMITED TO:**
 - ONE (1) LARGE and ONE (1) SMALL ANIMAL ENTRY PER EXHIBITOR.
 - Small Animals defined as: Rabbit Meat Pen, Meat Chickens and Turkeys
 - Large Animals defined as: Sheep, Goat, Swine and Beef
- **SANTA CRUZ AND MONTEREY COUNTY MARKET EXHIBITORS ARE LIMITED TO:**
 - ONE (1) ENTRY PER EXHIBITOR.
 - Market Beef, Goat, Sheep, Swine, Poultry Meat Pen, and Rabbit Meat Pen
- **NO MORE THAN ONE OWNERSHIP PER ENTRY:**
 - Livestock must be solely owned by and under exhibitor's care and management. Project must be under supervision of 4-H / FFA or Independent parent / leader to be eligible to show. Exception - horses and can be leased
- **PROTEST:**
 - Refer to State Rule V, rules 1 - 15. Decision of Livestock Superintendent cannot be protested and is final. All protests must be presented to the management of the Fair within 24 hours of the alleged violation or 24 hours after the results are available to the public of exhibits judged pre-fair. Protest must be accompanied by a \$500.00 deposit (cash, money order or certified check) which will be returned only if the protest is determined valid. Protest and appropriate action are decided by the Fair's Board of Directors or designees in a timely manner
- **EXHIBITOR WILL BE DISQUALIFIED:**
 - From his / her class, if he / she fails to be present and ready to perform within three (3) minutes from the time his / her class or number is called
- **CHAMPION AND RESERVE CHAMPION:**
 - All market species will return for Overall Grand Champion.
- **BEDDING:**
 - SHAVINGS ARE PREFERRED. Straw allowed where necessary. NO PELLETT BEDDING.
- **NO HANDS-ON POLICY:**
 - All Junior Livestock Exhibitors and all projects must be under the exhibitor's care and management. Junior Exhibitors (the owner of the exhibit) are required to groom their own animals, however they may be assisted in grooming, clipping, or blocking by another junior livestock exhibitor of the San Benito County Fair. Anyone who is determined by management to require help from an adult, shall be granted such, in writing prior to the Fair. The use of professional groomers will be cause for disqualification of the exhibitor and / or animal.

Disqualification consists of the withholding of premium money and ribbons, elimination from further competition and / or removal from the auction.

- **LIVESTOCK SHOW RING CODE OF ETHICS:**

- The member fairs of the Western Fairs Association are uniting to support ethical and humane treatment of all animals exhibited at our fairs and expositions, as well as reinforcing the educational emphasis of competitive programs for animals and maintaining the highest integrity standard of all participants. Henceforth, the member fairs of the Western Fairs Association have adopted drafts of the National Show Ring Code of Ethics as proposed by the American Livestock Show and Rodeo Managers Association in June 1995 and the Code for Show Ring Ethics drafted by the International Association of Fairs and Expositions as working guidelines for member fairs. The Show Ring code of ethics expresses the belief that we should exhibit animals on their own merits and each animal should be handled properly with attention towards its needs.

- **ANIMAL OWNERSHIP:**

SBCF minimum ownership requirements for 2024: NO EXCEPTIONS!

- Beef: Minimum of 120 days. MUST be tagged on or before June 3rd, 2024
- Lambs/Goats/Hogs: Minimum of 60 days. MUST be tagged on or before August 2nd, 2024
- Rabbits: Minimum of 30 days. August 30th, 2024 deadline. Bill of Sale required.
- Chickens: Minimum of 30 days. September 3rd, 2024 deadline.
- Turkeys: Minimum of 30 days. September 3rd, 2024 deadline
- Breeding: Minimum of 30 days. August 30th, 2024 deadline. Bill of Sale required.

- **STILL EXHIBITS:**

- See LOCAL RULES & REGULATIONS concerning requirements. Failure to comply will result in DISQUALIFICATION of all Market Entries for an exhibitor

- **PARKING:**

- ALL VEHICLES MUST BE PARKED IN DESIGNATED AREAS. Vehicles parked out of designated areas of the Fairgrounds will be towed away at the owner's expense
- If removing breeding animals, trailers may be brought in, animal loaded and then removed at designated times
- NO TRAILER PARKING ON THE FAIRGROUNDS DURING THE FAIR

- **AWARD THANK YOU CARDS:**

- Award Thank You cards are due in exchange for award on day of show. Thank You cards will be provided by Awards Chair.
- Thank You Buyer letters, by club, are due to the Awards Chair, April Mistretta Sunday, October 6th between 12:00 pm – 2:00 pm in the main arena. Envelope must be addressed, stamped, and unsealed.

- **BUYER THANK YOU LETTERS:**

- Thank You letters are due on Sunday, October 6th between 12:00 pm – 2:00 pm in the Livestock Office.
- Letters are to be turned in by Club only.
- MUST be addressed, postage stamp(s), and unsealed.

- **WATER CONSERVATION:**

- ONLY hoses with shut-off nozzle allowed. Exhibitors not using a shut-off nozzle will be notified by Security to leave wash racks. The San Benito County Fair appreciates your assistance in conserving water. Thank you.

- **PARTNER FOR A SAFE FAIR:**

- The goal of the Fair Board is to present a fair that is not only fun, but safe for exhibitors and other guests. We ask that all fair livestock exhibitors and their families observe safe practices in the barns. For the protection of our exhibitors and the preservation of the pens, there is to

be no climbing on the bars of the pens. Only proper electrical outlets should be used with no overloading or hazardous placement of cords. Reducing the risk of food contamination is critical. Observing the 'no food or beverage' policy in the barns is **REQUIRED**. Signs will be posted to remind both exhibitors and fair guests that food consumption is **PROHIBITED** in barns. Additionally, signs will stress the policy of guests not touching livestock. Hand washing is an essential protective practice for our exhibitors and guests alike. Postings will also be placed in and around the barns and hand washing stations. We thank our livestock exhibitors for their partnership in reducing potential risks.

- **FITTING AREAS: *NEW***

- U-Barn will be used for Fitting Area **ONLY** (Goats – Sheep – Beef). Sections will be marked.
- Large Generator with appropriate boxes and outlets will be provided. Personal Generators are allowed but **ONLY** in designated area and appropriate cords. **NO EXCEPTIONS!**
- **NO CANOPIES ALLOWED! NO EXCEPTIONS.**
- Premium Beef Fitting spots available at Barn H. \$25.00 each. Limited spots available. Limit 1 per exhibitor. 1st COME, 1st SERVE – LIMITED QUANTITY. Purchase at the Livestock Office, September 28th from 3:00 pm – 5:00 pm.

- **REST AREAS:**

- Ice chests allowed. **ONLY** non-alcoholic beverages allowed. **NO** cooking and/or BBQing of any kind allowed. Subject to search by security.

- **LIVESTOCK BARN AREAS:**

- **NO** tables, ice chests or BBQ's allowed.
- Two (2) chairs allowed. More than 2 will be asked to move to the rest area. Subject to search by security.

- **SECURITY FEE:**

- A \$5.00 Security Fee is included in the Entry Fee for large animals

2024 JUNIOR LIVESTOCK EXHIBITOR

CODE OF CONDUCT

The following Code of Conduct has been developed by the Board of the 33rd DAA, management, staff, and volunteers to ensure a safe and comfortable environment for our exhibitors, families, and guests at the San Benito County Fair. By submitting an entry to the Fair in the Livestock Department or any other Youth department, both the youth exhibitor and their parents / guardians and leaders who sign their forms, agree to these rules and the consequences should they be broken.

We are working to provide a place for young people to learn from their successes as well as their challenges. We understand that competition and working with animals in a new environment sometimes creates frustration. We feel that managing that frustration professionally and positively is a vital part of the learning experience. We require everyone on our grounds to always heed the following Code of Conduct during our event.

POLICY FOR EXHIBITOR CONDUCT

- Exhibitors must feed and care for their animals twice daily. Animals must be provided fresh water daily and their pens must be cleaned daily. Shavings should appear fresh and not be soaked with waste.
- Minors in possession of or being under the influence of alcohol on the Fairgrounds is prohibited and illegal. If this is suspected at any time during the Fair events, law enforcement will be contacted and the exhibitor risks removal from the grounds for the remainder of the events. Illegal drugs are NEVER allowed on the Fairgrounds.
- Smoking or vaping is not allowed in the Barns at any time or on the Fairgrounds for any exhibitor under 18 years of age.
- Any exhibitor acting violently, brandishing a weapon or item used as a weapon, fighting, or risking the safety of another exhibitor in any way, will be contacted by security / law enforcement, and removed from the grounds for the remainder of the events.
- Exhibitors must always remember they are representing their industry, their families and themselves to the public while they are at the Fair. Poor care of animals, hitting them hard enough to leave marks, excessive mess in the public areas of the barns, foul language, and loud boisterous behavior or fighting is against the code of conduct.
- Judges' decisions are final. Exhibitor will not talk back or argue with the judge or judges' decision.
- Posts on social media will be respectful to all and considerate of the Agriculture and Fair industries we are part of. Disparaging posts about Judges, staff, volunteers, or other exhibitors is against the code of conduct.

Violation of the Code of Conduct could result in the expulsion of the exhibitor, parents, club or chapter and their animals from the Fairgrounds. This includes forfeiture of awards, auction sales and possible suspension for future Fair activities. Please be kind, be safe and represent yourself, your family, and your community in an excellent way!

POLICY FOR ADULT LEADER / ADULT ADVISOR / PARENT / GUARDIAN

CODE OF CONDUCT

Adults have a responsibility to guide youth exhibitors by teaching, encouraging and setting good examples

- Respect and courtesy for other adults, leaders, staff, and volunteers is required at all times. Verbal or physical arguments between adults are not acceptable. We can teach our young people how to handle successes and frustrations with maturity and dignity. Fighting or loud arguments between adults is a violation of the code of conduct. If security or law enforcement is needed to intervene, the participating adults will be asked to leave the Fairgrounds immediately.
- Adults responsible for youth exhibitors will not carry, consume, or store alcohol in the barn area during the youth livestock show, sale and exhibit. Alcohol may be purchased from Fair vendors and / or at the JLA Auction hospitality area and enjoyed responsibly outside of the barn area. Carrying outside alcohol and / or leaving it where it is available to a minor is against the code of conduct.
- Judges' decisions are final. Parents and adults will not argue with the judge or judges' decision.
- Posts on social media will be respectful to all and considerate of the Agriculture and Fair industries we are part of. Disparaging posts about Judges, staff, volunteers, or other exhibitors is against the code of conduct.

Violation of the Code of Conduct could result in the expulsion of the exhibitor, parents, club or chapter and their animals from the Fairgrounds. This includes forfeiture of awards, auction sales and possible suspension for future Fair activities. Please be kind, be safe and represent yourself, your family, and your community in an excellent way!

4-H CLUB RULES AND REGULATIONS

- All eligibility and age limitations as per county 4-H participation Requirements (See Local Rules). The official 4-H show uniform must be worn by all 4-H exhibitors and by helpers in individual and club groups while showing. Horse Show and Livestock Shows shall consist of: 4-H cap (must be worn on head or with judges discretion), white shirt or blouse (short or long sleeve). Absolutely no midriffs or sleeveless shirts are to be worn. Pants may be white or black (no acid wash) must be long enough to cover the ankles. If pants have belt loops, a belt must be worn.

FFA CHAPTER RULES

- The official FFA Show Uniform to be worn by all FFA exhibitors and by helpers in individual and chapter groups while showing at fairs and livestock shows shall consist of white trousers, white dress shirt (short or long sleeves) with FFA emblem attached to the left pocket and the official FFA four-in-hand necktie. The official FFA jacket is **REQUIRED**; Judges will make the call for heat making jackets not required. Hats or headgear (except if showing in light horse classes) of any kind shall not be worn with the official show uniform while showing.
- Students competing in this division must be regularly enrolled in the high school vocational agriculture program and must meet the requirements, rules and regulations set up by the C.A.T.A. and the State Association of FFA.
- All entries in this division must be from projects carried as a part of the regular high school agricultural program and must be owned by the student

INDEPENDENT AND GRANGE JUNIOR EXHIBITOR RULES

- Exhibitors not affiliated with any organization can enter appropriate 4-H classes, if they meet the following requirements: Independent exhibitors must be at least 9 years old or in the 4th grade by January 1st of current year. Exhibitors are eligible to compete / exhibit through December 31st of the year in which they turn 19 years of age
- Independent Juniors must not have been in a junior organization within one (1) year of the Fair to be eligible to participate.
- Dress code for Independent Juniors for showing livestock:
 - White or solid black jeans – No acid wash
 - White shirt, long or short sleeves
 - Belt
 - Clean & polished boots or shoes – No pant legs tucked in boots
 - **ABSOLUTELY** no midriffs or sleeveless shirts
 - All independent exhibitors will show in 4-H division

FAILURE TO FOLLOW RULES AND REGULATIONS BELOW WILL RESULT IN FORFEITURE OF AWARDS AND/OR MONIES

- Leader / Advisor Signature Procedure:
 - Due to the online entry program our process to obtain 4-H leader and FFA advisor signatures is as follows: after entry closing date a list of all entries (livestock and non-livestock) for each club and chapter will be emailed to the 4-H Community Leader / FFA Advisor / Grange Leader.

There will be a one-page sheet for each leader / advisor to certify that all entries are valid projects and eligible to exhibit at the 2024 fair. This signed sheet MUST be emailed or mailed back to the fair by September 13th

- Tag Id and Scrapie Tag Numbers:
 - Tag Id Number(s) and Scrapie Tag Number(s) MUST be listed correctly on Entry Form. Animal will not be permitted to enter the Fair if number does not match entry form.
NO EXCEPTIONS
 - All Sheep and Goats MUST have a Scrapie Tag. Tag will be verified.
- All Livestock must arrive clean and in show condition
- Certificate of Drug Medication MUST be filled out, properly signed, and turned in at Receiving
- If a market animal is considered not market ready by the judge, the animal is not eligible for sale
- The exhibitor of any animal considered wild by the livestock committee will be asked to remove the animal from the fair.
- All animals must be able to be led by the exhibitor while at the fair.
- All exhibitors are responsible for cleaning, feeding, and watering their livestock until release on Sunday, October 6th.
 - Exhibitors not feeding or watering their animals will forfeit all awards and auction monies
- All market animals must be pre-tagged on specified dates. Parent and Exhibitor must be present day of tagging. In the event exhibitor and parent cannot be present, a leader or designated representative may fill in providing this change is approved by Fair management in writing two weeks prior to the tagging date.
Pre-tagging of an animal is NOT an automatic entry in the San Benito County Fair. Exhibitors must enter pre-tagged animals and pay all fees by the entry deadline to be eligible to participate in the fair.
- Three (3) entries will constitute a minimum class. Where entries are less than for a minimum class at the close of entry, the class may be cancelled or combined. This decision will be made by management and department chairs.
- Animals not sold through the auction, (breeding and feeders) MUST be removed from the grounds by 3:00 pm Friday, October 4th. All show birds MUST be removed from the grounds by 4:00 pm Sunday, October 6th.
- No practice roping or bicycles in livestock area, or anywhere during Fair.

POSTMORTEM EXAMINATIONS

- The San Benito County Fair reserves the right to perform a postmortem examination of any animal which dies at the San Benito County Fair. If required, this must be performed by an official veterinarian at the expense of the exhibitor.

San Benito County Fair Junior Livestock Auction is a Terminal Sale. No Live Pickups

- The San Benito County Fair, to encourage the boys and girls of San Benito, Monterey, and Santa Cruz Counties in their livestock project
- This is a terminal auction sale of market livestock starting at 9:30 am Saturday, October 5th
- All Beef, Sheep, Swine, Goats that are market ready will be sold at auction. Grand Champion & Reserve Champion, Third, Fourth and Fifth place meat pens of Rabbits and Poultry, if market ready, will be sold.
- When an entry is made in the market divisions, it is automatically consigned to the San Benito County Fair Junior Livestock Auction. This pertains to market ready animals only.
- Exhibitors and their leader / advisor **MUST** be present at the time of sale. If owner is not present, the animal will not be sold in auction, but it will be sold at market price established for resale animals. Owner must be in official uniform per Junior Livestock Special Rules. Owners / Exhibitors may have help from another exhibitor if needed, but **MUST** be present
- All livestock will be weighed Tuesday, October 1st. Each entry will be weighed only once. Substitutions will not be permitted.
- A Sales Fee of 8% will be charged by the Auction Committee on all animals sold, this includes Add-On's, to cover hauling and other expenses, including condemnation by Federal inspection. The following will be deducted from auction check:
 - \$1.00 from all Market Beef for Beef Promotion
 - \$0.40 per \$100.00 gross market value (0.4%) Selling Charge from all Swine for Pork Promotion
 - \$.007 per pound on lambs for sheep promotion.
 - A \$13.00 charge will be withheld from each auction check for all market animals to cover cost of two (2) 4" x 6" color pictures taken of each exhibitor and animal.
- Livestock order is determined by the auction committee. See below for order. Heritage animal will be sold at the conclusion of the sale.

- Animals must be sold through the Junior Livestock Auction to be eligible to receive any Add-On payments. Add-On minimum is \$50.00 per exhibitor.

**Junior Livestock Auction checks will be released
Friday, November 15th between 9:00 am and 4:00 pm**

- Sellers will be paid by check and released to 4-H Leaders, FFA Advisors, Grange Leaders and / or their designated representative at the San Benito County Fair Entry Office. Formal Proxy letters will be required. Independent Juniors can pick up their checks at that time. If checks need to be reissued for loss or stale date, a \$50.00 fee will be required to re-issue the check. Banks will not cash checks more than 6 months old.

4-H and FFA SHOWMANSHIP

ENTRY DEADLINE: August 25th

Entries accepted online only until 11:59 pm

RULES:

- Showmanship is included with entry fee. **Class MUST be entered separately in ShoWorks by entry deadline.** No refunds for non-participation
- American System of Judging
- Exhibitor must show their own market animal. Exhibitor can only show a breeding animal if this is the only animal they are exhibiting.
- All 4-H and FFA Horse Show exhibitors need to SEPARATELY enter Horse Showmanship.
- Exhibitors shall be on hand and ready to exhibit at the time called for judging. After one call if exhibitor is not present then he / she will be dismissed from the class.
No exceptions.
- First and second class winners of 4-H Novice, 4-H Junior and FFA Novice are eligible to advance to the next level of showmanship.
- All exhibitors are required to wear the show uniform of the organization they represent. (Girls may wear slacks instead of skirts.) See uniform regulations under Junior Livestock Special Rules.
- Only animals owned, fitted, and shown by the exhibitor in the Junior Livestock Department divisions are eligible. Horses in the Horse Show are also eligible.
- Rabbit Showmanship participants must wear long sleeve shirts or blouses.
- Showmanship classes are based on age as of January 1st of current year.

4-H PRIMARY SHOWMANSHIP (Poultry, Rabbits, Pygmy and Nigerian Dwarf Goats):

- Open to 4-H members from 5 years old to 9 years old and can show in the class every year until they become official 4-H age of 9 years old and in the 4th grade.

4-H NOVICE SHOWMANSHIP:

- Open to 4-H members 9 years old through 10 years old who have never shown this species of animal at any fair. Note: First and second place winners may advance to 4-H Junior Showmanship. Any member who has shown in Novice Showmanship at any fair will advance to Junior Showmanship.

4-H JUNIOR SHOWMANSHIP:

- Open to 4-H members 11 years old through 13 years old regardless of experience and number of years in 4-H. 9 years old through 10 years old who have already shown in Novice Showmanship at any fair. First and second place winners may advance to 4-H Senior Showmanship.

4-H SENIOR SHOWMANSHIP:

- Open to any 4-H member 14 years old through 19 years of age regardless of the number of years in 4-H.

FFA NOVICE SHOWMANSHIP:

- Exhibitors showing this species for the first time and that have never shown this species previously in this or any other organization. Note: First and second place winners may advance to FFA Advanced Showmanship.

FFA ADVANCED SHOWMANSHIP:

- Open to any FFA member regardless of the number of years showing.

- Rules, definitions, and judging procedures as prescribed in the current Handbook and Standard of the American Rabbit Breeders Association, Inc. shall apply to all District and County Fair rabbit shows, provided they do not conflict with any rules and regulations prescribed by the Department of Food and Agriculture.
- All animals must be permanently and legibly earmarked in the left ear. The tattoo is to only contain numeric 0-9 and / or letters A-Z. The tattoo is to contain no language of a profane or sexual nature.

- An exhibitor may not enter more than one animal in the same class with the same ear number or ear tag number.
- Rabbits not legibly earmarked must be disqualified from the class. Legibility of the earmark is at the discretion of the judge.
- Animals possessing an ear number that does not match the ear number on the exhibitor's entry form must be removed from the class and the class number reduced. No day of show ear number changes allowed.
- Rabbits are to be entered by age and weight requirements for that breed per the *Standard of Perfection*.
- The exhibitor is to check the show cards that are emailed prior to the show and notify the chairperson of any discrepancies to the fair entry. Day of show the exhibitor shall again check entry cards and report any discrepancies or scratches.
- Substitutions can only be made within the same breed and MUST be received in writing 5 days prior to the show. Only day of show changes allowed will be for an existing entry in their age class: i.e. a Junior to a Senior, Junior to Intermediate etc. This must be done prior to judging.
- **NO CHANGES WILL BE ALLOWED AT THE TABLE DURING JUDGING**
- Junior exhibitors are expected to groom and care for their animals when at the Fair. They may ask for assistance if they require help to safely place the rabbit on the show table.
- It is the responsibility of the exhibitor to take the rabbit to the show table when the class is called to be judged. Rabbits absent at the time of judging do not count when computing the number of rabbits in the class.
- The judge will eliminate from the show those animals which have disqualifications from competition. They will count when computing the number of rabbits shown in the class.
- Rabbits entered in a class that are the wrong sex, breed, or variety are to be eliminated from the class and the number in the class corrected accordingly.
- No rabbits allowed that do not meet minimum Pre Junior, Junior or minimum age requirements for that breed. No Does with litter will be allowed on grounds.
- Highest Placing 4-H Junior, 4-H Senior, and FFA Senior winners may advance to Round Robin competition. Please see the Round Robin division for notification deadline. Only 4-H and FFA members are eligible.

RULES:

- Showmanship class winners of 4-H Junior, 4-H Senior and FFA Advanced Showmanship in each livestock division (Market Goats, Dairy Goats, Sheep, Swine, Beef, Dairy Cattle, Horses, Rabbit and Poultry) have the opportunity to show in the Round Robin Class in which they won.
- Exhibitors, who should win more than one species of Showmanship, must designate the species they will represent during Round Robin and notify the species Chair at that time:

No later than Friday night at 5:00 pm in the Fair Livestock Office.

The second-place winner of a class NOT CHOSEN BY THE WINNER will then be eligible to compete. If the second-place winner chooses not to show, we will contact the following placings in order until a designated delegate for that species is secured to ensure a full class for Round Robin.

- If an exhibitor wins both Junior and Senior 4-H Showmanship for the same species, they have the option to pick which Round Robin class to participate in. The next placed exhibitor in the class not chosen will have the opportunity to participate until the delegate for the class is secured.
- Animals to be shown for Round Robin will be chosen by the Livestock Superintendent and Specie Chair.
- Exhibitors will be assigned numbers for animals to be shown.
- Exhibitors CANNOT show their own animal.
- If a defect or injury is found by exhibitor on animal, it must be mentioned to judge or Chair.
- Species shown will be Market Goats, Dairy Goats, Sheep, Swine, Beef and Dairy Cattle. No Horses, Rabbits or Poultry will be shown in the Round Robin competition; however, the winners of those species are still eligible to compete.

Species may be eliminated from competition if number needed is not sufficient to complete a round.

The showmanship winner of that species is still eligible to compete in Round Robin.

- If an exhibitor chooses not to show a species for any reason, that person can sit out of the class and receive the highest score relative to the number of exhibitors in the class. For example, nine exhibitors = 9 score for that species not shown. Judge's decision will be final.
- It will be at the Judges' discretion to have an animal removed if they deem necessary for any reason.
- Tie Breakers are decided with the most number of 1st's, 2nd's, etc. If a tie still exists, then then tie will be broken by the best score in knowledge.

FFA FEATURE BOOTH EXHIBITS

RULES:

- American System of Judging
- Ribbons Only - 1st - 3rd Place

- The feature exhibit booth provides members an opportunity to acquaint the public with a specific phase of their chapter program. The booth can show what they have learned, the activities in which they have participated or the contributions of their organization to the community. Judges will insist upon a high quality of products and materials used in the exhibit.
- Feature Exhibit Booths shall be limited to one entry by a chapter. A high scoring exhibit will be artistically arranged, colorful, attractive, and well lighted.
- Booths must be designed, constructed, and installed by organization members. The Chapter President, Vice-President or Secretary must sign the entry form.
- Exhibitors must plan to replace all fruits and vegetables that deteriorate during the Fair.

FFA FOOD & NUTRITION

RULES:

- **Entry must specify type of foods** by name (i.e., Bar Cookie, Drop Cookie, etc.).
- Food that needs refrigeration may be entered
- Deliver each exhibit displayed on a **disposable plate in a plastic bag**. A zippered

bag is preferred. Deliver one plate for display and one for tasting (including Recipe in a Jar)

- Minimum quantities:
 - Muffins, Biscuits, Rolls, Cookies, and Candies - 4 each
 - Cakes - 1/4 cake plus one slice
 - Breads - half loaf plus one slice
 - Pies - one standard 6" or larger.
- Identify with a note if baked goods are cooked in a way other than conventional, (i.e., microwave, low salt, fat or sugar free, low cholesterol).
- For Decorated Cakes Only: A Styrofoam or cardboard form **MUST** be used provided the shape is one which could be reasonably achieved through baking. **NO REAL CAKES**. Royal icing is recommended.
- No food will be returned.

FFA FOOD PRESERVATION

RULES:

- **Entry must list type of product**
- All food preservation, packaging, and labeling must list the method of process used. Low acid foods must be canned under pressure. Dried products should be wrapped in clear plastic or sealed jars. New screw rings must be used. Jar labels should list type of product and process. Label with Canning date on bottom of jar
- Fruits, Tomatoes, Juices, Vegetables, Jellies, Jams, Pickles etc.

Each entry to consist of two jars:

- 1 jar to be judged
- 1 jar for display
- Jerky: 6 Strips
- Dried Fruit: 6 - 8 sections
- Jam: May contain crushed, uniformly chopped or very small fruit or pulp depending on the kind of jam.
- Jelly: Natural for fruit. Bright, not faded or discolored. Free from sediment, cloudiness, crystals, fruit, or foreign particles. Anything with vinegar solution is a pickled fruit or vegetable.
- No paraffin.
- Open "Judged" canned goods MUST be picked up on Tuesday, October 1st - 4:00 pm - 7:00 pm
- Gift packs must be done by exhibitor consisting of homemade jams, jellies, or other homemade preserved items. May include other items to carry out the theme of the gift pack

- Label the back of each photo with exhibitor name, division, and class.

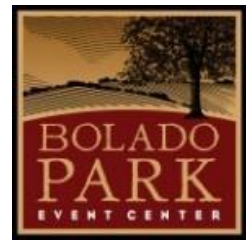
